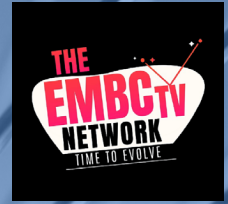
**TERMS OF THE AGREEMENT:**

**INDEMNIFICATION:**
